1. Introduction

We process your personal data in accordance with the **UK General Data Protection Regulation (UK GDPR)** and the **Data Protection Act 2018**.

2. What Information We Collect

We may collect and process the following information:

2.1 Personal Information

- Full name
- Contact details (address, telephone number, email address)
- Installation address (if different from contact address)
- Details relating to your property (for renewable energy installations)
- Payment details (where applicable)
- Any correspondence you send us

2.2 Technical Information

- IP address
- · Browser type and version
- Device type
- Website usage information (via cookies or analytics tools)

3. How We Collect Your Data

We collect personal information in the following ways:

- When you contact us via phone, email, or our website contact form
- When you enter into a contract or service agreement with us
- When we carry out a survey, installation, or maintenance visit
- From publicly available sources (for example, Companies House)

4. How We Use Your Data

We use your personal data to:

- Provide quotations and respond to enquiries
- Carry out installations, maintenance and related services
- Manage payments, invoices, and customer accounts
- Fulfil our contractual obligations
- Comply with legal or regulatory requirements (e.g., MCS, RECC)
- Improve our services and customer experience
- Handle complaints, feedback, and warranty requests
- Send important service updates or safety information

We **do not** sell, rent, or trade your data with third parties for marketing purposes.

5. Sharing Your Data

We may share your personal data with:

- Our approved installers, engineers, or subcontractors (for work purposes only)
- MCS certification bodies and the Renewable Energy Consumer Code (RECC), where required
- Warranty providers, product manufacturers, or finance partners
- IT and system service providers (for email and data management)
- Regulatory authorities or insurers where legally required

All third parties we work with are required to respect your data and use it only for legitimate business purposes in line with this policy.

6. How Long We Keep Your Data

We retain your personal data only as long as necessary to:

- Fulfil the purpose it was collected for
- Comply with legal and accounting requirements
- Support any warranty, guarantee, or dispute resolution process

Typically, this means keeping records for **up to 7 years** after the completion of work, unless a longer retention period is required by law.

7. Your Rights

Under data protection law, you have the right to:

- Access request a copy of the personal data we hold about you
- Rectification request correction of inaccurate or incomplete data
- Erasure request deletion of your data where there is no legal reason to retain it
- Restriction request limited processing of your data in certain circumstances
- Data Portability request a copy of your data in a transferable format
- Objection object to how we use your data, including for direct marketing
